This agreement (hereinafter referred to as "Agreement") is entered into between ABC COMPANY (hereinafter referred to as "Company") located at 12345 State Street, Anywhere, CA 12345, and Jane Smith (hereinafter referred to as "Client") located at 6789 Home Street, Elsewhere, CA 67890, on this date, March 24, 2015.

**RECITALS:**

The Client wishes to engage the Company to renovate Client's kitchen as described under "Scope and Manner of Services."

The Company hereby agrees to provide the Client with such services in exchange for "Payment for Services Rendered".

The parties agree that the terms set out herein constitute good and valuable consideration, the exchange of which is hereby acknowledged.

***Scope and Manner of Services***

The Company agrees to:

- 1) remove the major appliances and countertops in Client's kitchen at the above listed address and dispose of such appliances and materials in accordance with all applicable laws;
- 2) replace the major appliances and countertops with those set out in the attached "Addendum 1" to this Agreement;
- 3) complete this work by or before May 31, 2015, absent any unforeseen circumstances which may arise and are outside of the Company's control.

***Payment for Services Rendered***

The Client shall pay the Company for services rendered as follows:

- 1) down payment of \$2,500 due upon the execution of this Agreement;
- 2) additional payment of \$2,500 due upon installation of the new countertops by Company;
- 3) final payment of \$2,500 due upon completion of work.

Should the Client fail to pay the Company the full amount specified in any invoice within ten (10) calendar days of receipt of each invoice, as set forth herein, a late fee equal to two percent (2%) of said invoice amount shall be added to the amount due and interest of fifteen percent (15%) per annum shall accrue from the calendar day following the invoice due date. It is further agreed that Company shall suspend the completion of its work as set out herein until such delinquency has been cured by Client.

***Applicable Law***

This Agreement shall be governed by the laws of the State of California and any suit brought by either party arising out of a dispute over the terms and conditions of this Agreement shall be filed in the Superior Court of California, San Diego County.
